

~Waskesiu Canada Day Parade and Related Celebrations~

Waiver & Release

This Waiver & Release form must be brought to the attention of each individual wishing to participate in the Canada Day parade and related celebrations in Waskesiu and must be signed by such participant (or his/her legal guardian) prior to the beginning of the parade. If a participant has not signed this Waiver & Release form, they may be asked to immediately discontinue participation or involvement.

To: The Waskesiu Recreation Association Inc., Parks Canada Agency, Prince Albert National Park of Canada, and His Majesty the King in right of Canada, including each of their respective agents, employees, officers, directors, managers, volunteers, successors, and assigns (hereinafter collectively referred to as the “**Waskesiu Parties**”).

I, _____, hereby waive and release, indemnify, hold harmless and forever discharge the Waskesiu Parties, and each of them, of and from any and all claims, demands, debts, contracts, expenses, causes of action, lawsuits, damages and liabilities, of every kind or nature, whether known or unknown, in law or equity, that I have or may have, arising from or in any way related to participation in the Waskesiu Canada Day parade and/or any Canada Day related celebrations, events or activities (collectively, the “**Canada Day Events**”), hosted, conducted, organized, or operated by the Waskesiu Parties, or any of them, within the townsite of Waskesiu, Prince Albert National Park, provided that this waiver and release of liability does not apply to any acts of gross negligence.

I understand that some or all the Canada Day Events in which I participate, including the parade, may be inherently dangerous and can cause serious or grievous injuries, including bodily injury, damage to personal property and/ or death. On behalf of myself, my heirs, assigns, and next of kin, I waive all claims for damages, injuries and death sustained to me or my property that I have or may have against any of the Waskesiu Parties.

By this Waiver & Release, I assume any risk, and take full responsibility and waive any claims of personal injury, death, or damage to personal property associated with and including, but not limited to property, and/ or equipment in any manner, form of fashion, arising from or caused due to engaging in any Canada Day Events, including the parade, or other related activities.

If any participant is a minor, then as the legal parent and/or guardian of such minor child, I, hereby agree to accompany my child when he/she is participating in all Canada Day events, including the parade, and any additional activities occurring throughout the day. If at any time a representative of the Waskesiu Parties, or any of them, deems my child to be unsupervised or unaccompanied, they can refuse to allow my child and myself to further participate in any activity.

This Waiver and Release contains the entire agreement between the parties and supersedes any prior written or oral agreements between the parties concerning the subject matter hereof. The provisions of this Waiver and Release may only be waived, altered, amended, or repealed, in whole or in part, with the prior written consent of all parties. The provisions of this Waiver & Release will continue in full force and effect following the termination of the Canada Day Events and related activities for the benefit of each of the Waskesiu Parties for such maximum period as may be permitted by law.
